INSTRUCTIONS FOR AN ADULT NAME CHANGE

A. Obtain Relevant Documents

- 1. You will need to get an original Right of Review (also known as a background check) from Louisiana State Police. You will need to contact them if you need assistance with this report.
- 2. Legible copies of relevant documents.
 - a. State Driver's License or Identification Card
 - b. Birth Certificate

B. Complete the Petition for Adult Name Change

- 1. Once your Right of Review is completed and returned to you, you can complete the entire petition for name change, inserting your own personal information.
- 2. Get the verification page notarized and sign all documents.

C. Deliver Your Petition

- 1. First, submit your Petition for Adult Name Change, along with the Right of Review and Copies of the Relevant Documents to the District Attorney's Office to Answer.
- 2. Next, once it is approved by the District Attorney's Office, you can then submit your Petition to the District Court for approval.
- 3. Finally, once your Petition for Name Change is approved by the District Court Judge, all signed documents will need to be submitted to the Clerk of Court (337) 437-3550, along with the check or money order for the filing fee. (You will need to contact the Clerk of Court to find out how much it will cost to file it.). Be sure to get enough certified copies to provide to the various entities that you want to inform of your new name, such as Vital Records, Office of Motor Vehicles, etc.
